Dr. Martin Luther King, Jr. (January 15, 1929 - April 4, 1968), a Baptist minister, led the Montgomery Bus Boycott in 1955, co-founded the Southern Christian Leadership Conference in 1957, and served as its first president. His efforts led to the March on Washington in 1963. There, King delivered his "I Have a Dream" speech and galvanized the civil rights movement. The Department of Fair Employment and Housing (DFEH) is California's civil rights agency, which protects Californians from employment, housing and public accommodation discrimination, and hate violence. The DFEH investigates, conciliates, mediates, and prosecutes violations of the Fair Employment and Housing Act (FEHA), Unruh Civil Rights Act, Disabled Persons Act, and Ralph Civil Rights Act.
