This emergency rulemaking by the Department of Food and Agriculture expands the quarantine for the Asian Citrus Psyllid ("ACP") *Diaphorina citri* near the Traver area of Tulare County into an incorporated area of Kings County. This emergency action will provide authority for the state to perform quarantine activities against ACP within this additional area.

OAL approves this emergency regulatory action pursuant to sections 11346.1 and 11349.6 of the Government Code.

This emergency regulatory action is effective on 8/23/2016 and will expire on 2/22/2017. The Certificate of Compliance for this action is due no later than 2/21/2017.

(11) In Kings County:

(A) In the Kettleman City area: ....

(B) In an Unincorporated area: Beginning at the intersection of S 8th Avenue and Kings County Boundary Line; then, starting northeasterly along said line to its intersection with Kings County Boundary Line; then, southerly along said line to its intersection with Excelsior Avenue; then, westerly along said avenue to its intersection with 7th Avenue; then, northerly along said avenue to its intersection with Denver Avenue; then, westerly along said avenue to its intersection with 8th Avenue; then, northerly along said avenue to its intersection with an Imaginary Line at the terminus of said avenue; then, northerly along said line to its intersection with Cairo Avenue and N 8th Avenue; then, northerly along said avenue to its intersection with S 8th Avenue; then, northerly along said avenue to the point of beginning.
